



Christmas Assistance Application

This program helps provide Christmas gifts (toys) to families who are in financial need with children ages 0-13 (Children born after 12/25/2006). This year (2019) applications will only be accepted in person with a brief interview. The following documents must accompany the application. No assistance will be given without proper paperwork.

1. Valid Picture ID You must be the parent or have proof you are the legal guardian for the children.
2. Proof of income- All documents must be current
 - Current Medicaid card for each child OR
 - Free/Reduced school lunch paperwork OR
 - Food Stamp Award Letter (card will not be accepted) OR
 - Paycheck stubs for past 2 pay periods, last month's bank account statement showing disability, unemployment, social security, child support, other income.)
4. One ID for Each Child being registered that shows their date of birth (current Medicaid Card, Birth Certificate). This can also be proof that you are the parent or legal guardian, if your name is on it.
5. Official custody or guardianship papers if you are not thbiological parent.
